#### 4. Judicial Review of Refusal to pay Child benefit

FLAC has been given leave to judicially review the refusal of the Department of Social & Family Affairs to pay Child Benefit to an asylum seeker who successfully appealed the rejection of her initial application. A Social Welfare Appeals Officer upheld the woman's claim in February 2008 but the Department sought a review of the decision by the Chief Appeals Officer and refused to pay the benefit in the interim. The woman is still awaiting the result of the review application and has not been paid since February.

#### 5. Ex Lord Chief Justice condemns Iraq invasion

Lord Bingham, former Lord Chief Justice of England and Wales and senior Law Lord, has described the invasion of Iraq by the US and Britain as a serious violation of international law and accused the US and UK of acting like 'world vigilantes'. Lord Bingham was giving his first major speech since his retirement.

### 6. Lithuania pays €40,000 for transgender operation

Lithuania has paid €40,000 for a transgendered man to have gender re-alignment surgery outside the country. The European Court of Human Rights last year found Lithuania had breached the man's rights because it had failed to pass legislation that would have allowed him to have the surgery in the country. The Court ordered Lithuania to pass the legislation or pay for the man to have the operation abroad. So far no legislation has been passed.

7. Declaration of incompatibility with European Convention of Human Rights made relating to a law allowing local authorities to evict tenants without first holding an independent inquiry

On 11 November 2008, Mr. Justice Iarfhlaith O'Neill declared that s. 63 of the Housing Act 1966 is incompatible with Article 8 of the European Convention on Human Rights (ECHR).

The provision in questions allows for possession orders for council houses when there is a genuine dispute as to the reason for the order.

The case surrounds a man, Liam Gallagher, who claimed that he was entitled to success to his mother's tenancy at a house in Coolock, Dublin after her death in 2005. After discovering that Mr. Gallagher had not resided at his mother's home for two years prior to her death, Dublin City Council rejected Mr. Gallagher's application and issued a notice to quit and demanded for possession in 2006. Mr. Gallagher claims to have been living with his mother continuously except for a short period in the nineties. The case went before the District Court which made a finding of fact upholding his claim, but the court then expressed concern the s. 62 of the Housing Act did not allow the court to assess the merits of applications for possession orders. These points were then referred to the High Court for clarification.

The judge said that Mr. Gallagher should not be made to take High Court judicial review proceedings in order to acquire procedural safeguards and that this would have been avoidable had the council put in places the procedures that would safeguard his rights. This was the case in particular in light of a previous declaration of incompatibility handed down my Ms. Justice Mary Laffoy in the case of *Donegan v. Dublin City Council & Ors* [2008] IHEC 288 earlier this year. In this case the same provision of the Housing Act was held to be incompatible with Article 8 of the ECHR because it allows councils to evict tenants for antisocial behaviour with no opportunity to challenge the allegations against him before a court or impartial tribunal. The judge ruled that this was disproportionate in a case where the person was at risk of losing their home.

In all, the Gallagher case is the third declaration of incompatibility with the ECHR. The first declaration was handed down in the *Foy* case in October 2007. The question of whether the Government will respect the declarations and amend the laws which have deemed incompatible with the Convention remains to be answered.

## 8. European Court of Human Rights intervenes on behalf of Nigerian woman to under threat of deportation

The European Court of Human Rights in Strasbourg has intervened at the eleventh hour to ask the Irish Government not to deport a Nigerian woman and her two children who claim they are at risk of female genital mutilation.

Ms. Pamela Izevbekhai has been living in Sligo for the past four years with her two daughters aged six and seven. A previous daughter died in 1994 aged 18 months after being forcibly genitally mutilated in Nigeria. Ms. Izevbekhai fears the same fate for her two surviving daughters if they were to return to Nigeria. The practice of female genital mutilation is classified by the UN as torture and has said that states have the responsibility to take all the necessary measures to eradicate it.

Ms. Izevbekhai applied to the High Court for an injunction to delay her deportation until the Irish courts had determined her judicial review challenge to a refusal by the justice minister last March to consider her claims for "subsidiary protection" here. The court ruled, however, that it could not interfere with a valid deportation order where there were no new or exceptional circumstances since the case had been assessed by the two statutory bodies involved in the asylum process.

The European Court of Human Rights will now rule on the case, it will look at whether it is reasonable to expect the Izevbekhai family to relocate in all the circumstances of the case, and whether it will be safe. If it finds that it is not reasonable to expect them to do so, it will mean that the family cannot be sent back to Nigeria but it will not entitle them to refugee status in Ireland.

#### 10.New Government Plans on Rendition

The Government plans to approach the new US administration on the issues of extraordinary rendition, detention at Guantánamo Bay and the use of torture to interrogate prisoners. It is reported that the Government will also act to ensure that Gardaí and airport authorities have powers of search and inspection of aircraft.

The Government has established a Cabinet committee on aspects of international human rights. The Committee includes Ministers Eamon Ryan and John Gormley of the Green Party and the Minister for Foreign Affairs, Micheál Martin, the Minister for Justice, Dermot Ahern and the Minister for Transport, Noel Dempsey. The committee has agreed to contact the transition team of the new US president-elect Barack Obama seeking a clear commitment on the cessation of the above activities.

The committee will examine and strengthen legal provisions to allow Gardaí and airport authorities to have adequate legal powers for search and the inspection of aircraft and may include the provisions of the Air Navigation and Transport Acts.

The Minister for Justice will provide an update on the implementation of a programme for government commitment in relation to Garda human rights training.

Until now, the Government has insisted that strong personal assurances from the highest level in the US Government were acceptable to them to ensure that the US had not engaged in extraordinary rendition through Ireland.

In the Shadow Report to the Third Periodic Report of Ireland under the International Covenant on Civil and Political Rights published by FLAC together with the Irish Council for Civil Liberties and the Irish Penal Reform Trust earlier this year, it was recommended that the Government establish an independent inquiry into the illegal transfer of detainees through Irish airports. It was further recommended that the Gardaí should set up an investigations mechanism to regularly monitor and perform spot checks on CIA planes and CIA chartered flights.

The current Programme for Government states that "The Government will prioritise effective enforcement of a) Criminal Justice (United Nations Convention Against Torture) Act 2000, b) the Geneva Conventions 1962-1998. To that end the Government will encourage and support An Garda Síochána in the investigation and enforcement of these statutes...by making resources available for specialised training...to ensure effective protection for the

dignity of all persons within or passing through the State. We will ensure that all relevant legal instruments are used so that the practice of extraordinary rendition does not occur in this State."

#### 11. Universal Declaration of Human Rights goes into orbit

On 14 November 2008, the Universal Declaration of Human Rights travelled into space as part of the commemoration events to mark the 60<sup>th</sup> anniversary of the declaration which was adopted by the United Nations on December 10, 1948. This date now represents the annual International Human Rights Day worldwide. The document will remain in permanent orbit around the Earth in the Columbus multidisciplinary space laboratory in the European module of the International Space Station. An astronaut from the European Space Agency (ESA) has said that the document will "symbolically find its place 'above' all the peoples of the world." Two plaques with the inscription of the thirty articles of the Universal Declaration in English and in French were presented to the Director General of the ESA earlier in the month.

#### 12. Nepal to end discrimination on the basis of sexual orientation

The Supreme Court of Nepal has instructed the country's government to end all sexual orientation-based discrimination and to extend equal rights to gender minorities, including same-sex minorities. The order was made last week as a result of a case brought by a number of gay rights groups. It follows a ruling of the court in December 2007 that recognises homosexuals as citizens under the classification "third sex".

Last week's decision means that all gender minorities must be defined under the law as "natural persons". It directs the Nepalese government to establish a committee to draft a same-sex and marriage act, drawn from similar legislation in other countries. The country's first openly gay Member of Parliament has hailed the ruling as a "landmark decision".
