2012 Thomas Addis Emmet Fellow

Valerie O'Driscoll was the 2012 recipent of the Thomas Addis Emmet Fellowship. A final year BCL International student at University College Cork, Valerie spent eight weeks working in Seattle as a legal fellow in the Washington Appleseed Centre for Public Interest Law.

Washington Appleseed is a non-profit which seeks to achieve social justice through working closely with community advocates and utilising *pro bono* resources. Valerie had the opportunity to work on a number of projects during her time in Seattle.

Valerie was primarily involved in research for a forthcoming Washington Appleseed School Disciplinary Report. The report covers the impact of Washington State school discipline policies on children and the community.

Other Washington Appleseed projects that Valerie worked on include the campaign against the death penalty in Washington State and research on the lack of mental health supports for school children.

As well as working with Appleseed, Valerie was a research assistant with Professor Walter Walsh in the University of Washington.

Valerie also attended classes at the University of Washington, which were given by a variety of different professionals in the legal field, from Supreme Court judges to law librarians to prosecutors and defence attorneys.
